

Friends of Mineralogy, Inc. Midwest Chapter Annual Business Meeting Minutes - November 18, 2017 Barbara Kuss Deer Science Center, Wittenberg University Springfield, Ohio

<u>Called to order</u> by President Kenneth Bladh at 9:34 AM, after declaring a quorum. The following officers were present: Kenneth Bladh, President; Randy Marsh, Vice President Programs; Jeff Spencer, Treasurer; Clyde Spencer, Liaison; Frank Konieczki, Secretary. Vice President Field Trips Reggie Rose was unable to attend. Seven members were present.

The following items/topics were presented and discussed:

- 1. President Bladh welcomed all attendees. He asked if any corrections to the May 6, 2017 meeting minutes, as published in the July-August, 2017 newsletter, were necessary. No changes to the minutes were proposed or adopted. A motion was requested and subsequently made to accept the minutes as published. The motion was affirmed by unanimous consent. (RMarsh/JSpencer/P).
- 2. A request for a motion to approve the meeting agenda was made, the motion was proposed and passed without opposition (CSpencer/RMarsh/P).

3. Officer Reports:

Treasurer's Report: Treasurer Jeff Spencer indicated that a comprehensive financial report was available in the November-December edition of the newsletter. He provided highlights of the report, specifically that this year's beginning balance was \$5,527.89. This includes \$1,580 in dues income and also \$1,025 in non-dues income, for a current total of \$2,605.00 in revenue. The yearly disbursements to date are \$2,445.78, yielding a current balance of \$5,687.01. There is a surplus of \$159.22 for 2017. Jeff also commented that the treasury balance is usually highest at year's end because we have already paid our obligations and many members submit their annual dues prior to the new membership year. FoM Midwest had a total of 115 members in 2017, and 37 paid their dues in 2016 with 78 paying in 2017. One member has paid 2018 dues to date. The 2018 symposium budget is \$1,000, and there is \$240 in funds earmarked to fund it.

<u>Vice President Programs Report</u>: Randy Marsh provided a summary of the 2017 Chapter activities. He noted that there were three meetings held this year, which is less than the requirement contained in the by-laws. He indicated that some meetings are held in conjunction with other events (i.e. GeoFair). He suggested having a meeting in conjunction with the annual safety training since the training is well attended. Also to possibly move the meeting (and training) several weeks earlier so that it would not be too close to the date of the annual symposium. Randy also proposed that holding a meeting in conjunction with one or more local rock and mineral shows, such as those held in Mansfield, Columbus, Bedford and Detroit, might be a good idea. He also suggested that we could also explore the possibilities of having information booths or sales tables at one or more of these venues to augment the sales table at GeoFair (see the last paragraph of the VP Programs report).

There was extensive information and discussion regarding the 2018 annual symposium. Vice President Marsh reminded those present that the event will not focus on one specific topic with the goals of providing a broader spectrum of topics and more participation by students. The keynote speaker will be Dr. Peter McGaw, who will focus on hydrothermal Ag deposits. Other speakers include Dr. Peter Richards (distorted crystals) and Mark Jacobson (Chinese mineral collecting or Pike's Peak minerals). The afternoon session will feature presentations by students, and possibly a talk by Dr. John



Rakovan. Several students have already expressed interest in participating. There was discussion as to whether there should be a registration fee for the symposium. It was generally agreed that our organization's finances are sound and having an admission fee might discourage attendance, especially if it was tiered. It was observed that the fees received would not significantly impact FM's financial status, so having registration fees might prove to be more problematic than beneficial. Resultantly, Vice President Marsh proposed to not have a registration fee for the 2018 symposium, and the motion was carried (CSpencer/TBolka/P). Subsequent discussion about the possibility of monetary awards for graded/judged talks by students ensued, and a motion was made to award the following prizes for student presentations: 1st place- \$200; 2nd place- \$100; 3rd place- \$50. The motion was unanimously affirmed (RMarsh/MRoyal/P). Judging criteria will need to be developed. Randy Marsh will contact the organizers for the Rochester Mineralogical Symposium as a starting point for development. President Bladh graciously volunteered to be a judge. The topic of the respective roles of FoM Midwest, Miami University, and Cincinnati Gem and Mineral Society was also discussed. The impetus for the discussion was a name change for the event that was published in the CMS newsletter that reflected joint sponsorship by the three aforementioned organizations. However, the event is, in FoM's opinion, a mineralogical symposium sponsored by FoM, hosted by Miami University's Karl Limper Museum, with partial financial support for the keynote speaker provided by CMS. Vice President Programs Marsh will draft a charter for the symposium in the near future. Randy also indicated that Dr. John Rakovan will step back from his current symposium role after 2018, but Miami University will continue to host the event.

Vice President Marsh is currently seeking volunteers for the swap table at the Cincinnati GeoFair. Randy and his wife Heather have been setting up and manning the tables for several years, as well as storing all of the minerals at his house. He would like to step back from the role. This would normally be organized by the Fundraising Chairman; however, the position has been vacant for several years. President Bladh indicated that he can provide space at Wittenberg University to store minerals for the event.

<u>Vice President Field Trips Reggie Rose:</u> President Bladh provided the update on field trips on Vice President Rose's behalf, based on Vice President Rose's previous e-mail communication with President Bladh on October 18, 2017. The tentative 2018 field trip schedule is: April- Marblehead, OH; May- Penfield, NY and Junction, OH (Auglaize); July- South Rockwood, MI; October- Walworth, NY and Genoa, OH. If the Genoa trip is moved to September, we would still be looking for collecting opportunities for June and August.

Further information regarding the topic of field collecting will be included in Liaison Clyde Spencer's report.

<u>Liaison Officer Report:</u> Clyde Spencer indicated that the intent of 501c organizations is to serve the community, so it would be a good idea to expand our services for the public, such as providing grant funding or outreach. He also indicated that the outreach could include support of existing outreach groups from other organizations.

Liaison Officer Spencer provided information about several collecting locations. He has been communicating with management at the Harding Street Quarry, but the most recent information provided by quarry staff indicates it will be several years before the quarry is accessible. Vice President Field Trips Reggie Rose and Scott Kell met with the new manager of the Williamsport quarry at the OAIMA conference, but the former manager, who was instrumental in getting FoM access to the quarry, did not attend. Stoneco indicated FoM will be able to collect there in the future, but they did not provide a specific time frame. Portage quarry was viewed as a possibility, since it had reopened in 2016 for a large project; however, no fresh blast rock is currently available. Maumee is currently barren of mineral rich material.



Bellevue was also a possibility, but encroachment has limited any clear access to possible collecting area(s). Liaison Spencer spoke with the plant superintendent at Plum Run and tried to schedule a field trip, but he has been unsuccessful to date. There was also discussion about returning to a pair of collecting sites in Missouri that were accessed two years ago. A suggestion was made to possibly coordinate with one or more local clubs regarding field trips.

Clyde addressed the topic of a new service provided by FoM Midwest, specifically, mineral identification (ID), and that a framework for it is being established. Providing the service may attract members and potential members to Chapter events, making these events more useful and impactful. The initial committee members for mineral ID will be President Bladh and Liaison Spencer. Clyde is actively seeking volunteers for the committee, especially long-time Ohio collectors who are able to readily identify specimens and also their localities. This will be started on a small scale. Members, along with their families and friends, can bring a few items for identification. The identifications will be free and will be considered "best guess", non-binding opinions. Liaison Spencer suggested that any specimens that are subject to paid analysis and funded by FoM Midwest, based on case-by case recommendations would be reported in the newsletter.

4. Old Business: None.

5. New Business: The nomination and election of officers for 2018 was the first item. The floor was opened for nominations, the proposed slate of officers was: Ken Bladh, President; Randy Marsh, Vice President Programs; Reggie Rose, Vice President Field Trips; Jeff Spencer, Treasurer; Clyde Spencer, Liaison Officer; Frank Konieczki, Secretary. Noteall are incumbent officers in the positions for which they were nominated. A motion was made to accept the aforementioned slate of officers, the motion was carried by unanimous acclimation (CSpencer/MRoyal/P). There are also two Committee Chairs, namely the Newsletter Committee Chair and the Fund Raising Committee Chair. Tom Bolka agreed to continue in his current role as Newsletter Committee Chair. The position for Fund Raising position remains vacant.

Annual dues were briefly discussed, and because of the organization's financial stability, and projected income and disbursements, a motion was introduced for dues to remain the same (\$20 per member) in 2018, and unanimously passed (CSpencer/RMarsh/P).

The President's annual message was presented, and it included the following topics: forming a subgroup to consider Chapter boundaries and expanding the number of collecting sites; creation of a mineral ID Committee; volunteer opportunities; input welcomed from members; personal gratitude for mentoring received during the year, and thanks to the officers for their work; highlights of the year (several). Secretary's note - As noted in the succeeding paragraph, the entire President's annual message will be included in the upcoming newsletter, so to avoid duplication, only a brief description was provided in these meeting minutes.

6. <u>For the Good of the Order:</u> Vice President Programs Randy Marsh suggested the President's annual message be included in the next FoM midwest newsletter, and subsequently be submitted to the national newsletter.

A motion was made to adjourn the meeting (KBladh/MRoyal/P). It was carried without opposition.
