

#### PRESIDENT'S MESSAGE

Those of you chapter members who know me, know that I love field collecting either locally here around Bloomington or as part of field trip groups going into Midwest quarries. This winter the Bloomington, IN area has been cold and snowy with relatively few chances to get out and locally field collect Indiana geodes. So to avoid boredom, I have done many inside projects most, if not all of the questies, which how visits, require that you have 450 at (Mino Sale)? Hazard) Training,

One of my bigger undertakings has been to review on line mineral dealer web sites. How many of you visit or have visited on line mineral dealer web sites? And how many of you have purchased, or thought of purchasing specimens online? visit many sites on a more or less regular basis, but have only rarely bought a specimen online (very few hi quality Indiana geodes for sale!). Anyway, I picked about 30 sites from advertisers in "Rocks and Minerals" and "Mineralogical Record". The web sites ranged between those thought of as selling predominantly moderate priced specimens and those dealers usually thought of as "high end". The sites were both domestic and foreign. All sold wholly or predominantly mineral specimens with little else.

I found a wide range of quality in these web sites. And I don't mean quality of the sale specimens offered, but quality of the sites themselves. A few of my findings even surprised me and are noted below. All are somewhat subjective and personal opinions. So, if you go to these web sites, see if you agree or have differing opinions. As part of my review, I needed some criteria that I thought important to the site's quality evaluation so here is some of what I thought 3 IS THE SITE COMPLETE 1 THE SITE'S EASE OF USE 2 IS THE SITE UPDATED OFTEN WITH ALL ASPECTS OF A DEALERSHIP 4 ARE THE PIX WITH EACH SPECIMEN OF HI QUALITY 6 IS THE SITE MISLEADING IN ANY WAY. Here are some of my (somewhat SPECIMEN'S INFO COMPLETE subjective) findings.

First, and most importantly, many dealer web sites were good to excellent with no real problems and no individual dealer site will be named. But some web sites were not up to snuff. A few had picture quality and specimen info issues.....usually minor, but would you by a specimen that you could not really check out?

Several dealer sites seemed really neglected. Much old material was offered, even from 2006 and 2007 with nothing new added in months. Very irritating was "SOLD" across very old material that had never been removed from the site. Some screens even had " SOLD, SOLD, SOLD" on all the undeleted specimens from months or even years ago. A few sites did NOT list prices; which I believe is okay for very hi end P.O.R. specimens, but never for specimens less that four figures. At least one dealer site was actually a museum. Many very hi end specimens were pictured with info, but no prices. After hunting all his fine print, it was noted that ALL the pictured items had been handled in the past and NONE were for sale. The individual might be a dealer, but his web site is more a museum of what has been.

After all was said and done, my biggest peeve was the neglected sites. And there were several. In these there was little to no attempt to update and freshen the web site up. For example, one site mentioned the dealer attending shows in 2007 and 2008! Specimens seemed to be added, but none was removed when sold or even noted as being sold, and no longer unavailable. Prices from several years ago had not been reduced on lower quality unsold specimens etc etc.

So, fellow collectors and chapter members, when you take time to surf the internet, think critically of the dealer web sites GOOD (ONLINE) HUNTING!! with whom you do business
